- (3) Court Room 4 - Appeals & Judicial Reviews
- (4) Court Room 6 - Civil Court Three (3)
- (5) Court Room 7 - Civil Court Four (4), Human Rights, Election Petitions, Leadership Tribunals, etc.
- (6) Court Room 8 - Civil Court Two (2)
- (7) Court Room 9 - Civil Court One (1)
- (8) Court Room 10 - Commercial

These arrangements are subject to the need to use either Court Room 1, 2, or 3 when the nature of a case may require the need to use these Court Rooms. When the need to swap these court rooms arise that Judges consult one another personally has been the current practice.

It is to be understood that the Daily Diary is a guide only. The time, hearing date and Court for a particular case, whether on this Daily Diary or not, should be confirmed at the Registry or with the associate of the Judge presiding over a particular Court.
